6. Terms and Conditions

1. The Participant shall comply with all relevant laws affecting it's participation.
2. The participant shall take out public liability insurance with a limit of liability of no less then \$10M and indemnifies and will indemnify the organiser, its agents, servants, contractors and employees from all actions, claims, demands, losses, damages, cost and expenses arising from the participant's use of the site and in particular but without limiting the generality of the foregoing against any loss, damage or injury from any cause whatsoever to the property or person caused by or contributed to by the use of the site by the participant or any servant, agent or other person duly authorised by the participant whether such loss, damage or injury occurs on the site or not and whether caused by any act, omission, neglectt, breach or default of the participant or any other person.
3. At the option of the organiser, the participant is required to provide evidence of the required insurances and the organiser has the right to reject the insurance on the grounds it does not meet the obligations contained herein or because the insurer is not acceptable to the organiser.
4. The participant shall not, without the prior consent of the organiser, permit any person other than the participant, its servants or agents to occupy any part of the site. Should this condition not be observed, the organiser may charge an additional fee for basic package or exercise any other of its rights under this agreement.
5. The organiser reserves the right to cancel this agreement and to retain any money paid or to recover any money not paid in relation thereto without assigning any reason for such cancellation and retention or recovery.
6. All property of the participant is brought on to the Nosh on the Namoi site at the risk of the participant and the participant hereby agrees to indemnify and hold indemnified the organiser against any action, claim, demand, loss, damage, cost or expense in relation to any loss, damage or injury to such equipment however occasioned.
7. The organiser reserve the right to alter site allocations at its discretion.
8. The organiser shall be responsible only for the provision of the services specified on the 2012 Exhibitor Registration form, and does not warrant to provide any other services whatsoever.
9. All stall holders selling or handling food must copply with the NSW Food Authority's Temporary Food Event Guidelines.
10. To comply with the Occupational Health and Safety Act, the participant is responsible for the creation and maintenance of a safe environment for both their workers and visitors including the use of safe and suitable extension leads and power boards that have been tagged and tested.
11. All cancellations must be in writing and the organisers reserve the right to charge a 25% cancellation fee for cancellations received before 16th March 2012.
